## **Speaker Bios**



Major General Daryl L. Bohac serves as The Adjutant General, Nebraska National Guard, Lincoln, Nebraska. As the Adjutant General, he is the senior uniformed National Guard officer responsible for formulating, developing, and coordinating policies, programs and plans affecting more than 4,800 Army and Air National Guard personnel. Appointed by the Governor, General Bohac serves as a principal on the Governor's Staff and is the Director of the Nebraska Military Department and the Nebraska Emergency Management Agency, respectively and serves as the state's official channel of communication with the National Guard Bureau to the Departments of the Army and Air Force.

General Bohac was commissioned in 1988 at the Air National Guard Academy of Military Science, McGhee-Tyson Air National Guard Base, Tennessee. Prior to receiving his commission, General Bohac served as an enlisted member of the United States Marine Corps Reserve and the Nebraska Air National Guard. He deployed in support of Operation Enduring Freedom as the Senior Air Reserve Component Advisor for Air Force Central Command, Al Udeid Air Base, Qatar from December 2008 to May 2009.



Bryan Tuma currently serves as the Assistant Director for the Nebraska Emergency Management Agency having been appointed to this position by Major General Daryl Bohac effective June 23, 2014. Mr. Tuma previously served with the Nebraska State Patrol for nearly 32 years and was appointed as the Superintendent of Law Enforcement and Public Safety by Governor Dave Heineman on June 4, 2005. Mr. Tuma served as the agency director for the Nebraska State Patrol until his retirement on March 1, 2011.
